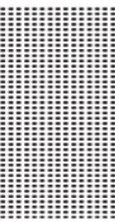


Application Form for Personal Data Processing Permit According to Article (5) of the Personal Data Protection Law

Pursuant to the provisions of the Personal Data Protection Law issued by Royal Decree No. (6/2022) and its Executive Regulations concerning the procedures for obtaining a permit from the competent authority prior to processing any of the personal data set out in Article (5) of the aforementioned Law, please complete the required information in this form in a clear and accurate manner.

Before completing this form, you are required to review the provisions governing the processing of personal data as stipulated in the Personal Data Protection Law and its Executive Regulations and ensure compliance therewith. You are also required to declare that you are not subject to any of the exemptions provided for in Article (3) of the Law by placing a mark (✓) next to each item.

- ☐ Protecting national security or public interest.
- ☐ Implementation of the units of the administrative apparatus of the state and other public legal persons of the competences prescribed to them by law.
- ☐ Implementation of a legal obligation imposed on the Controller by virtue of any law, judgment or decision by the court.

- ☐ Protecting a vital interest of the personal data subject.
- ☐ Detecting or preventing any criminal offense based on an official written request from the investigation entities.
