1 Overview

1.1 Document Purpose

The Business Architecture of the Oman eGovernment Architecture Framework (OeGAF) comprises two architecture elements, namely the government-wide lines of business and the associated government functions performed by the Oman Government.

The BRM defines and provides the detailed description of these government-wide lines of business and the associated government functions. Establishing this government-wide view will enable the prioritisation of government functions to be streamlined and centralised or common Information and Communications Technology (ICT) systems to be implemented, leading to overall efficiency of the Oman Government and greater convenience to the constituents of government services.

1.2 Objectives and Benefits of BRM

The BRM is one of the fundamental components of OeGAF. It defines the different lines of business and the associated government functions of the Oman Government that cut across the boundaries of different agencies.

Through this government-wide perspective of lines of business and government functions, the BRM provides an insight for identifying potential government functions for streamlining and optimisation of business processes, and for consolidation and integration of ICT systems.

The Oman Government will be highly effective and efficient in performing its functions as a result of the follow up efforts to streamline and optimise business processes, and consolidate and integrate ICT systems. The final beneficiaries will be the citizens, residents and commercial establishments in Oman as they will enjoy greater convenience and better user experience when they transact with the Oman Government.

Hence, the development of BRM is important and necessary to support the objectives of the following eOman Strategic Pillars, established in 2008 to guide Information Technology Authority (ITA) in its implementation of eOman Strategy:

- (a) National Infrastructure Development
- (b) Enhance Government Performance
- (c) Development of Standards, Policies, Procedures and Regulations.

Figure <u>BA-1</u> depicts how the BRM supports the above mentioned eOman Strategic Pillars.




Figure BA-1: BRM Supports the eOman Strategic Pillars

With proper follow through, the BRM will bring about the below benefits:


- (a) Enhance interoperability across government agencies
- (b) Facilitate move towards shared services
- (c) Leverage on current ICT investment and assets
- (d) Improve user experience, achieve cost savings, and reduce complexity
- (e) Augment the governance practices through clearer accountability
- (f) Align ICT projects of government agencies to central ICT initiatives.

1.3 Background on Oman eGovernment Architecture Framework

OeGAF consists of four main architectures as follows:

- (a) Business Architecture
- (b) Solution Architecture
- (c) Information Architecture
- (d) Technical Architecture.

Each of the architecture has a corresponding Reference Model. Each Reference Model describes a framework to define and organise the architecture elements. Figure <u>BA-2</u> depicts the overall OeGAF Reference Architecture.

The OeGAF four Reference Models are:

The **Business Reference Model (BRM)** describes the different lines of business and the associated government functions of the Oman Government that cut across the boundaries of different agencies.

The **Solution Reference Model (SRM)** describes the common applications and application components that can be shared across the Oman Government. It includes the technical standards and security considerations pertaining to the design and implementation of solutions and applications.

The **Information Reference Model (IRM)** lists the data definitions and data elements of common and shared data that are used across the Oman Government. As part of the initial baseline scope, IRM describes the data

pertaining to 'Person', 'Establishment' and 'Land' data hubs which are commonly used by various agencies' applications. It also defines technical standards, design and security considerations and best practices related to the management of data.

The **Technical Reference Model (TRM)** defines the infrastructure technologies and their respective technical standards to enable better system integration and interoperability across the Oman Government. It also defines the security considerations and standards related to the infrastructure technologies.

The mention of the technologies and technical standards in the TRM, IRM and SRM is to provide logical and easy reference for readers.

1.4 Relation to Other OeGAF Reference Models

The BRM is the key fundamental component of OeGAF, and the governmentwide government functions defined will influence the development of the SRM and IRM as follows:

(a) For SRM, the BRM provides the insight for identifying potential government functions for streamlining and optimisation of business processes, and for consolidation and integration of ICT systems. For example, through the BRM (see Section 4.18 below), it is easy to identify a need for a One-Stop-Shop system to be implemented that allows online application of all commercial establishment licenses.

Please refer to SRM for the detailed list of common and shared systems identified.

(b) For IRM, the lines of business and government functions defined in BRM will aid the discovery of data required by the government functions that will result in the creation of conceptual data model. For example, through the BRM the following central repositories can be easily identified for detailed definition in IRM:

 (i) Central repository of data on citizens and residents required to support the Civil Event Records Maintenance function (see Section 4.3 below)

- (ii) Central repository of data on commercial establishments required to support the Licensing and Regulatory Control of Commercial Establishments function (see Section 4.18 below)
- (iii) Central repository of data on land information required to support the City Planning and Development function and Land, Building and Public Facilities Development and Management function (see Section 4.2 below).


In addition, the involvement of the primary¹ and enabling² agencies in the government functions identified in Section **Error! Reference source not found.** below can also be utilised to assign data ownership. In this context, the guiding principle is that the primary agency would be most likely the source of data and resulting in being the natural candidate to be data owner. Refer to the IRM for further details.

The BRM is indirectly related to TRM through SRM and IRM, as TRM defines the infrastructural standards for the use by SRM and IRM.

Figure <u>BA-3</u> below provides a pictorial overview of how the BRM is related to SRM and IRM.

1.5 Scope of Business Reference Model

The scope of BRM covers the complete government-wide perspective of lines of business and the associated government functions for the current available list of government agencies. Thus, the BRM does not include all government agencies, but it does cover a comprehensive list of the key ministries, councils, authorities, municipalities and boards.

The definitions of line of business and the government function are as follows:

- (a) Line of business is a broad category of government functions
- (b) Government function is specific business activities associated to a line of business.

The lines of business defined are further categorised into two areas of business as follows:

- (a) Services to Citizens, Residents and Commercial Establishments These are lines of business with government functions that directly serve the citizens, residents and commercial establishments.
- (b) Internal Corporate and Support Services
 These are activities that support the delivery of government services and ensure the effective operations of the Oman Government.

1.6 Target Audience

The BRM treats the Oman Government as a large business enterprise when defining its lines of business and the associated government functions. Hence, the BRM is a business architecture document that provides a good representation of the business of the Oman Government. Upon careful study of the BRM, it will provide a thorough insight into the different functions of the Oman Government business.

The target audience for the BRM are therefore as follows:

(a) Government Senior Executives

The BRM provides the senior executives in the Oman Government a valuable government-wide view of the government business. The BRM will be a useful input to these senior executives when initiating government-wide planning and streamlining the government functions.

(b) Strategic Planners in ITA

ITA is the central agency established to drive the implementation of eOman Strategy. The BRM can be used by the strategic planners in ITA to identify potential common government functions and the agencies that can be involved in cross-agency collaboration. Business process workshops can then be subsequently conducted to facilitate discussion amongst agencies and derive projects on shared processes, systems and data. This will lead to improved government operations efficiency and effectiveness when the projects are implemented.

(c) ICT Directors/Managers in Agencies

ICT directors/managers in agencies can use the BRM to find out which other agencies are also involved in the same lines of business and government functions. This can then trigger feasibility studies and collaboration opportunities amongst the agencies to derive common business processes. It can also be used to identify potential shared systems and data sharing opportunities.

In addition, for agencies developing their very own specific business reference models, the BRM is a useful reference that will help agencies in identifying relevant functions in their areas of responsibility where close collaboration with other agencies is required.

1.7 BRM Design Principles

It is important when defining the lines of business and the associated government functions that we are not restricted by the current functions and boundaries of agencies. Instead, a government-wide perspective should be adopted. The below design principles are established to guide the definition of lines of business and the associated government functions through a government-wide perspective.

Principle 1: Integrated View of Government Functions Independent of Agency Boundaries

The lines of business and the associated government functions are defined based on a whole-of-government approach that categorise related government functions together, regardless of the agencies that perform such functions. An integrated view is essential in identifying and implementing whole-of-government ICT systems that deliver seamless services to the citizens, residents and commercial establishments of Oman.

Principle 2: Focus on Alignment of Agencies Activities as Logical Business Functions

Different agencies' activities are group together through a business focus approach to provide a holistic view of the government functions. It will facilitate improvement of business processes in the Oman Government, resulting in more efficient and higher quality public services.

1.8 Governance of BRM

The ongoing management and execution of BRM is part of the overall governance of OeGAF as stated in the final OeGAF document. It includes reviewing and updating the lines of business and the associated government functions defined. New lines of business and government functions may be added when necessary.

2 Lines of Business and Government Functions Definition

2.1 Definition Approach

The BRM defines the different lines of business and the associated government functions of the Oman Government that cuts across the boundaries of different agencies. In addition, unlike commercial enterprises whose core business activities are clearer and more instinctive, government business is diverse and there is no singular set of overarching whole-of-government business objectives.

There is also no generic BRM on government-wide lines of business and government functions available for adaptation by OeGAF. Moreover, it is not practical to adapt the lines of business and government functions defined by other countries as the government model and the national issues and priorities vary from country to country.

To meet the objectives of OeGAF, a whole-of-government and business-driven approach was adopted when defining lines of business and the associated government functions for the Oman Government. Information on the vision/mission statements, functions/objectives and organisation structures of the government agencies were obtained from the following credible sources:

- (a) Translated Royal Decrees
- (b) Information collected by ITA from agencies for its implementation of central initiatives
- (c) Agencies English websites
- (d) Guide to Administrative System in Oman published by Institute of Public Administration (IPA).

The gathered information were studied and analysed to establish a three-level hierarchy for BRM shown in Figure <u>BA-4</u> below:




Figure BA-4: Three-Level Hierarchy of BRM


2.2 Structure of BRM

The BRM uses a three-level hierarchy structure to describe the business of Oman Government in the following manners:

- (a) Two areas of business that categorise the lines of business are as follows:
 - Services to Citizens, Residents and Commercial Establishments are external customer facing services that Oman Government provides.
 - (ii) Internal Corporate and Support Services are activities that support the delivery of government services and ensure the effective operations of Oman Government
- (b) There are twenty one lines of business in the Services to Citizens, Residents and Commercial Establishments business area and three lines of business in the Internal Corporate and Support Services business area. The lines of business in each business area are further categorised as follows:
 - (i) Vertical lines of business refer to government services that relate directly to a business domain

- (ii) Horizontal lines of business refer to common government services that can be found across different business domains
- (c) Within each line of business are a set of associated government functions.

Figure <u>BA-5</u> below provides an overview of the Oman Government lines of business.

3 Improving Performance of Government Functions


3.1 Intent

The intent of this section is to help government agencies to understand, review and improve the performance of their respective government functions and processes.

In the previous section, the line of business (LOB) and the corresponding government functions within the LOB were defined. This section, on the other hand, will guide government agencies on the steps to improve their government functions.

3.2 Role of Government Functions in OeGAF Architecture Vision

The Oman Government functions and processes play a vital role in the OeGAF architecture vision. To deliver quality eServices to the citizens, residents and businesses and, at the same time, to improve the government efficiency, the government functions and processes have to be continuously reviewed and improved. Figure BA-6 describes the overall OeGAF Architecture Vision. As highlighted in the figure, the requirements of the government businesses will drive the implementation of relevant ICT solutions, information/data and infrastructure to deliver quality eServices to the beneficiaries.

3.3 Guide for Continuous Improvements of Government Functions & Processes

Zooming into the 'Agency Business' layer itself will lead us to Oman Government Businesses architecture components as shown in Figure <u>BA-7</u> below.

OeGAF Architecture Vision (Version 2.0) Oman Government Businesses




Figure BA-7: Oman Government Businesses Architecture Components

The following steps will guide government agencies to improve the performance of their respective government functions and processes.

(i) Understand Your LOB and Government Functions

Each government agency can refer to <u>Section 4</u> below to understand its LOB and related government functions. It is important to note that each government agency would typically have functions that span over more than one LOB.

For example, while the Ministry of Education is the primary agency for the Education LOB, this ministry is also responsible for other government functions such as licensing & regulatory control of private schools, monetary collection especially schools fees, procurement of goods & services for all the schools, and the management of public information on education-related information to parents and public.

Each government agency should also compare the policies and responsibilities as defined in Royal Decrees, and match them to the various government functions.

(ii) Prioritise the Government Functions and Processes for Improvements

From the list of the government functions and processes, a government agency should give priority to those functions where the agency is responsible as a **primary agency**. The primary functions and processes should be given priority for improvements over the enabling functions and processes.

In alignment with the *Oman eGovernment Transformation Plan*, all government agencies have to also prioritise and implement eServices that are beneficial to the citizens, residents, commercial establishments/businesses and other government agencies. With the prioritised primary government functions carried out above, the list of eServices to be implemented would also be naturally prioritised as well.

(iii) Carry Out Business Process Improvements

For the prioritised government functions and processes, it is recommended to carry out a business process improvements or even a business process re-engineering. The objective is to review, innovate and develop better business processes that would lead to improvements in internal efficiency and deliver better eServices.

The business processes are typically divided into four categories – customer facing, internal, government-to-government and government-to-private.

Note that these improved business processes should be documented. Subsequently, the appropriate ICT solution(s) can be implemented to

support the newly improved business processes or eServices (please refer to Solution Reference Model for details).

(iv) Explore Opportunities With Other Government Agencies

Each government agency should never plan and implement projects and services on its own. Every government agency would rely on other agencies to fully carry out its responsibilities and functions. In Figure BA-7 above, the key integrated business processes were identified based on their social and economic impacts on delivering value-added services to the public. Government agencies who are involved in these government-wide integrated business processes have to collaborate among a number of related government agencies to implement the improved business processes. Government agencies who have business licensing function, for example, can work with the Ministry of Commerce and Industry to jointly develop integrated process to approve the application for new or renewal of commercial establishments.

<u>Section 4</u> lists the details of LOBs and functions so that each government agency can easily identify the other agencies that it has to work with.

To further aid the integration work among government agencies, ITA has consolidated a list of Shared Services and Central Initiatives that would speed up the implementation and integration of improved business processes and eServices. Government agencies can approach ITA for more help and coordination effort with other agencies to jointly develop and implement integrated projects and eServices.

4 Mapping of Government Lines of Business with Government Agencies

This section describes the various government functions within each line of business. It also lists the government agencies that are responsible for the respective government functions.

For a quick reference on mapping of government agencies to their line of business and government functions, please refer to <u>Appendix A</u>.

4.1 Arts, Culture and Tourism

This category of government functions involves preservation and promotion of culture, arts and heritage to the public and tourists.

Figure <u>BA-8</u> below shows the government functions associated with the Art, Culture and Tourism line of business.




Figure BA-8: Government Functions of Arts, Culture and Tourism

Primary agency that is overall responsible for the management and maintenance of monuments, museums, historic buildings, archives and historical records and manuscripts.

(b) Ministry of Tourism

Enabling agency responsible for the management and maintenance of castle and forts under the care of the ministry.

(c) Ministry of Information

Enabling agency responsible for the approval of national artworks for display and circulation.

(d) National Records and Archives Authority

Enabling agency responsible for the setup of necessary processes, standards, policies and procedures to govern the management of documents archival and information assets across ministerial agencies.

(e) Diwan of Royal Court

Enabling agency responsible for the management of Centre for Islamic Culture.




Figure BA-9: Government Functions of City Planning, Development and Management




Figure BA-10: Government Function of Civil Events Record




Figure BA-11: Government Functions of Community and Sports




Figure BA-12: Government Functions of Economic Development




Figure BA-13: Government Functions of Education




Figure BA-14: Government Functions of Environment Management




Figure BA-15: Government Functions of Health




Figure BA-16: Government Functions of International and Trade Relation




Figure BA-17: Government Functions of Law and Justice Management & Administration




Figure BA-18: Government Functions of Manpower Development and Social Insurance Protection




Figure BA-19: Government Functions of Monetary Control and National Loans Management




Figure BA-20: Government Functions of National Defence and Security




Figure BA-21: Government Functions of Natural Resource and Food Reserve Management




Figure BA-22: Government Functions of Religious Affairs




Figure BA-23: Government Functions of Research and Development




Figure BA-24: Government Functions of Transportation and Communication




Figure BA-25: Government Functions of Licensing and Regulatory Control




Figure BA-26: Government Functions of Monetary Collection






Figure BA-27: Government Functions of Public Information Management and Communication




Figure BA-28: Government Functions of Procurement of Goods and Services




Figure BA-29: Government Functions of Royal and State Affairs




Figure BA-30: Government Functions of Corporate Planning and Development




Figure BA-31: Government Functions of Information and Communications Technology Enablement and Management
