Oman Transport Safety Bureau "OTSB" is an independent operational and administrative unit for air and marine accidents and incidents investigations under the direct supervision of the Minister of Transport, Communications & Information Technology, the Chairman of the Board of Directors of CAA under the Ministerial Decision No. 19/2018, based on Chapter X from the Oman Civil Aviation Law 76/2019 and in compliance with ICAO Annex 13 requirements & International Maritime Organization IMO MSC 255 (84).

The sole objective of OTSD investigations is the prevention of accidents and incidents and it is not the purpose of this activity to apportion blame or liability and outlining the Just Culture.

The OTSB is financially, administratively and operationally independent from the Regulators CAA and DGMA.

The OTSB maintains a 24/7 notification service receiving all reported events through hotline, e-mails and web forms.


OTSB was able to overcome and develop in many dimensions and keep strong engagement with stakeholders both locally and internationally.

The report outlines OTSB's performance, achievements & progress since the establishment of the OTSB.




AAIS REPORT

AAIS REPORTED OCCURRENCES BY CATEGORY


